Traveling north on downtown Main Street, turn left onto Elmwood Avenue. Continue on Elmwood (stay in the right lane), which will turn into I-26. Exit I-26 at the first St. Andrews Road exit. Turn right onto St. Andrews Road and continue to Broad River Road. Turn left on Broad River Road and continue approximately ½ mile to Huffstetler Drive. Turn left on Huffstetler Drive and you will see the school on the left. If traveling from Main Street to Broad River Road, pass Dutch Square Mall and continue across I-20. At the sixth traffic light from I-20, turn left onto Hofstadter Drive. The school will be on the left.
