Dear Parent/Guardian:

The Family Educational Rights and Privacy Act (FERPA), a federal law, requires that Richland County School District One, with certain exceptions, obtain your written consent prior to the disclosure of personally identifiable information from your child's education records. However, Richland County School District 1 may disclose appropriately designated "directory information" without written consent, unless you have advised the District to the contrary in accordance with District procedures. The primary purpose of directory information is to allow Richland County School District One to include this type of information from your child's education records in certain school publications. Examples include playbill, showing your student's role in a drama production, the annual yearbook, honor roll or other recognition lists, graduation programs, school television shows and newsletters, podcasts, school promotional activities and sports activity sheets, showing weight and height of team members.

Directory information, which is information that is generally not considered harmful or an invasion of privacy if released, can also be disclosed to outside organizations without a parent's prior written consent. Outside organizations include, but are not limited to, companies that manufacture class rings or publish yearbooks, and publicity/media releases (interviews, photographs, video, etc.) which may include newspapers, television, and the Internet. In addition, two federal laws require local educational agencies (LEAs) receiving assistance under the Elementary and Secondary Education Act of 1965 (ESEA) to provide military recruiters, upon request, with three directory information categories—names, addresses and telephone listings—unless parents have advised the LEA that they do not want their student's information disclosed without their prior written consent.

In the event that conditions necessitate that schools transition into adopting an eLearning platform our teachers will use a virtual platform as a way to facilitate the creation of classes, post assignments, and organize information for students. While this is a major step in supporting instruction, it does present additional considerations for parents around their child's privacy. Please carefully read the attachment to the letter "Virtual Classroom and Related Services Group Participation Confidentiality Notice and Parent Consent Form" which must be signed if you do not give your consent for your child to participate in group video and/or audio conferencing for the purposes of virtual learning.

Finally, if you do not want Richland County School District One to disclose any directory information from your child's education records without your prior written consent, you must notify your child's school in writing by September 30, 2021. Richland County School District One has designated the following information as directory information: student's name, address, telephone listing, photograph, date of birth, major field of study, dates of attendance, grade level, participation in officially recognized activities and sports, weight and height of members of athletic teams, degrees, honors, and awards received, the most recent educational agency or institution attended. Richland One also considers the voice, image, and likeness of a student in pictures, videotape, film, or other medium, as well as student work intended for publication or display to be directory information.

"Virtual Classroom and Related Services Group Participation Confidentiality Notice and Parent Consent Form"

As we transition into this new school year, our teachers may use Microsoft Teams as a way to facilitate the creation of classes, post assignments, and organize information for students. Please note that through this program, all students participating will be able to see each other's names and student email address.

Teachers and therapists may also be using a live video feed such as Microsoft Teams, Google Meet, or Zoom to interact with all students, including students with disabilities. This could occur with individual students, in small groups, or with whole classrooms. By joining a virtual group, you agree to participate and acknowledge that your child's name (first and last) will be accessible to other student participants. With live video feeds, we are also unable to control who else may be in the room when a student is receiving these services remotely. The parent or guardian of students participating may also be present, supporting them in their remote classroom time at home. Staff for student review purposes may record these sessions later. If your child is participating in-group instruction utilizing online platforms, please note that it may be possible for parents of other children in the group to see your student. Please maintain confidentiality and respect the privacy of all students during this period of remote learning. Unauthorized audio or video recordings (including screen captures, photos, etc.) of these sessions may be unlawful. Any recordings must be made and used in accordance with the Family Educational Rights and Privacy Act (FERPA) and state law. We will be taking all reasonable measures to preserve your privacy and the privacy of your student(s). If at any time, you are not comfortable with having your child participate in a Virtual Meet using an online platform such as Microsoft Teams, Google Meet, or Zoom, please reach out to your child's teacher or related service provider to review other options of program delivery.

Richland One expects that all families review and implement the following guidelines and expectations to ensure that the confidentiality rights of all students are protected when live videos are used.

- 1. Parent or Guardian shall make every effort to ensure that no one other than the student scheduled to participate can see or hear the live virtual session.
- 2. The parent, guardian, or student of virtual live sessions will make no recordings.
- 3. If parental or other third-party involvement in a virtual live session is necessary to enable a student to participate, the individual assisting the student shall not re-disclose any personally identifiable information about any student participating.
- 4. When participating in a group intervention, please be mindful of the educational environment and eliminate distractions that may divert the students' attention away from learning.

If you do not give your consent for your child to participate in group video and/or audio conferencing for the purposes of virtual learning, please sign the FERPA Parent Form below and please contact your child's teacher/provider/principal. Thank you for your support.

FAMILY POLICY COMPLIANCE OFFICE

The Family Educational Rights and Privacy Act (FERPA) (20 U.S.C. § 1232g; 34 CFR Part 99) is a Federal law that protects the privacy of student education records. The law applies to all schools that receive funds under an applicable program of the U.S. Department of Education.

FERPA gives parents certain rights with respect to their children's education records. These rights transfer to the student when he or she reaches the age of 18 or attends a school beyond the high school level. Students to whom the rights have transferred are "eligible students."

Parents or eligible students have the right to inspect and review the student's education records maintained by the school. Schools are not required to provide copies of records unless, for reasons such as great distance, it is impossible for parents or eligible students to review the records. Schools may charge a fee for copies.

Parents or eligible students have the right to request that a school correct records which they believe to be inaccurate or misleading. If the school decides not to amend the record, the parent or eligible student then has the right to a formal hearing. After the hearing, if the school still decides not to amend the record, the parent or eligible student has the right to place a statement with the record setting forth his or her view about the contested information.

Generally, schools must have written permission from the parent or eligible student in order to release any information from a student's education record. However, FERPA allows schools to disclose those records, without consent, to the following parties or under the following conditions (34 CFR § 99.31):

School officials with legitimate educational interest;

Other schools to which a student is transferring;

Specified officials for audit or evaluation purposes;

Appropriate parties in connection with financial aid to a student;

Organizations conducting certain studies for or on behalf of the school;

Accrediting organizations;

To comply with a judicial order or lawfully issued subpoena;

Appropriate officials in cases of health and safety emergencies; and

State and local authorities, within a juvenile justice system, pursuant to specific State law.

Schools may disclose, without consent, "directory" information such as a student's name, address, telephone number, date and place of birth, honors and awards, and dates of attendance. However, schools must tell parents and eligible students about directory information and allow parents and eligible students a reasonable amount of time to request that the school not disclose directory information about them. Schools must notify parents and eligible students annually of their rights under FERPA. The actual means of notification (special letter, inclusion in a PTA bulletin, student handbook, or newspaper article) is left to the discretion of each school.

The Protection of Pupil Rights Amendment (PPRA) (20 U.S.C. § 1232h; 34 CFR Part 98) applies to programs that receive funding from the U.S. Department of Education (ED), PPRA is intended to protect the rights of parents and students in two ways:

It seeks to ensure that schools and contractors make instructional materials available for inspection by parents if those materials will be used in connection with an ED-funded survey, analysis, or evaluation in which their children participate; and It seeks to ensure that schools and contractors obtain written parental consent before minor students are required to participate in any ED-funded survey, analysis, or evaluation that reveals information concerning:

- Political affiliations;
- Mental and psychological problems potentially embarrassing to the student and his/her family;
- 3. Sex behavior and attitudes;
- Illegal, anti-social, self-incriminating and demeaning behavior;
- Critical appraisals of other individuals with whom respondents have close family relationships;
- 6. Legally recognized privileged or analogous relationships, such as those of lawyers, physicians, and ministers; or
- Income (other than that required by law to determine eligibility for participation in a program or for receiving financial assistance under such program).

Parents or students who believe their rights under PPRA may have been violated may file a complaint with ED by writing the Family Policy Compliance Office. Complaints must contain specific allegations of fact giving reasonable cause to believe that a violation of PPRA occurred.
