

The N.E.S.T Afterschool Detention Program

GUIDELINES AND PROCEDURES

MISSION:

The mission of The N.E.S.T Afterschool Detention Program is to provide academic, physical, and psychosocial enrichment. The N.E.S.T Afterschool Detention Program will support the school's core curriculum and policies.

GOALS: *Increase* student academics through tutoring and *decrease* behavior through interventions.

HOURS OF OPERATION:

The N.E.S.T. Afterschool Detention Program operates Tuesday and Thursday from 3:20 pm to 4:20 pm when school is in session. **All students are expected to be picked up by 4:30 pm.**

LATE PICK-UP:

If your child remains in the care of The N.E.S.T Afterschool Detention Program passed 4:45 pm three times. The student will be unable to attend the program for any services.

PROGRAM SERVICES:

The N.E.S.T. Afterschool Detention Program offers a variety of services (e.g., tutoring, detention, and psychosocial development).

PARENT and STAFF COMMUNICATION:

The parent and staff relationship are extremely important as we work together to educate our students. The afterschool director will contact a parent if there are concerns about your child. Parents, please be sure that all phone numbers on file are correct and up to date. If you have a concern, or a problem arises, parents are encouraged to contact an administrator or the Afterschool Directors as soon as possible. Contact information is listed on the following page.

DISCIPLINE PHILOSOPHY AND PROCEDURE:

The N.E.S.T Afterschool Detention Program will follow the discipline philosophy and procedures of Lower Richland High School. We expect students to exemplify attitudes and actions which reflect the policies of Lower Richland High and Richland One School District. **If the student is consistently misbehaving, the Afterschool Director will be forced to remove the student from receiving future services. Physical aggression, hostile behavior, intimidating acts of harassment, extortion, violent behavior, or possession of weapons will not be tolerated.** Anyone who demonstrates such behavior will be held accountable for their actions and **will not** be allowed back into the afterschool program for services for the duration of the year. Please read below bullet points for additional expectations while attending The N.E.S.T Afterschool Detention Program.

- Afterschool services will be held in _____.

- All students must arrive and sign in by 3:30 pm (**NO EXCEPTIONS**).
- Students must bring their laptops to complete ABE modules during detention or work for tutoring services.
- There will be no talking, eating, or drinking during detention.
- There **will be no cellphone** use during detention.

STAFF:

The N.E.S.T Afterschool Detention Program hires only qualified/ certified staff to work in the afterschool program.
